Following a distinguished career in investment banking as an expert in mergers and acquisitions, and in management consulting as an expert in corporate governance and strategic growth, he also currently co-manages a diverse portfolio of investments in venture capital, private equity and public equities through the KT Family Trust.

Petros's involvement as Board Director and/or adviser has contributed to the significant and successful growth of a broad array of companies during the past thirty years. Mr. Kitsos is a Phi Beta Kappa graduate of Hamilton College, and holds an MBA with honors from Harvard Business School. He also attended St. Antony's College, Oxford. Prior, Mr. Kitsos served as Alumni Trustee of Hamilton College from 2004 to 2008 and as Alumnus Trustee of Anatolia High School from 1999 to 2003. Petros also served as Director and chair of the Compensation Committee of a public company in which the Trust was (at the time) a significant investor; as Board member, member of the Board of Managers and as designated Representative-in-Charge of Operations at Beacon Rail Leasing SARL (Lux.), and as Board member of Aries I Special Purpose Acquisition Corp. before, during, and after its Initial Public Offering and stock exchange listing.
