

Official Rules – NGFCU YOUth Month Jeopardy Trivia Game April 2025 (“Game”)

NO PURCHASE NECESSARY. ALL ENTRIES HAVE AN EQUAL CHANCE OF WINNING. CONTEST OPEN TO NORTHROP GRUMMAN EMPLOYEES. VOID WHERE PROHIBITED BY LAW.

1. How to Enter: The “Northrop Grumman Federal Credit Union (NGFCU) YOUth Month Jeopardy Trivia Game April 2025”. There are two time slots. The East Coast contest begins at 5:00:01 pm (ET) and ends at 6:00:00 pm (ET) April 24, 2025 (“Promotional Period”). Each Game consists of two winners that will be determined on April 24, 2025. One 1st place winner who ends with the most points and one second place winner who has the second highest points. If there is a tie, there will be a tie breaker trivia question. Only one time slot can be attended.

2. Eligibility: Contest is open to all Northrop Grumman employees or contractors who are age 18 or older at time of entry. NGFCU employees and volunteers, their immediate families and persons living in their households, whether related or not, are not eligible. Void where prohibited or restricted by law. The Contest is subject to all applicable federal, state, and local laws and regulations. In the event of conflicting law, the law of California will prevail.

3. Odds: The estimated odds of winning a prize for a particular contest depend on the total number of eligible attendees.

4. Prizes: 1st place is one (1) \$50 Lego gift card. 2nd place is one (1) \$25 gift card. These will be awarded during the Game period.

5. Drawings and Notification: There will be two winners in each online session. First place winner will receive one (1) \$50 Lego gift card and second place winner will receive one (1) \$25 Lego gift card. The determining of the winners will be held on April 24, 2025. If there is a tie for 1st or 2nd place there will be one tie breaker question to determine the winners.

6. Notification: Winners will be notified online during the event. They will be contacted after the event by phone at the phone number provided or by e-mail at the e-mail address provided. Should a winner decline the prize or not respond within 2 days of notification, an alternate winner may be selected from the remaining eligible entries, at Sponsor's sole discretion. Winner's acceptance of a prize constitutes permission for the Sponsor to use winner's name, address (city and state only) information and likeness, for advertising/publicity purposes and in all forms of media (including posting on web site), in perpetuity, without further notice to or compensation in connection with said Sweepstakes or the prize awarded.
